**Online transmission:**

- you must complete the "Identification of the respondent" section of your electronic form as soon as possible. Once the document is saved, an email will be generated by the system and sent to your respondents, informing them of the procedure to follow to complete the letters. It is strongly recommended that you ensure that you have received this e-mail ;
- since the letter is written in electronic format, you will be able to see the transmission date of this letter directly in "Your file";
- the letters of reference must be completed no later than October 10, 2014, at 4 p.m.

**INSTRUCTIONS TO THE RESPONDENT**

Please draft the letter of reference according to the evaluation criteria indicated below.  
You must draft the letter on the electronic form.

**Online transmission:**

- once you have received the instructions by email, you may begin writing your letter;
- if you do not already have a personal identification number (PIN), you must obtain one in advance on the Fonds de recherche du Québec - Société et culture Web site. With your PIN and your password, you will be able to access the letter of reference. You will also need the applicant's PIN and application number to complete the letter of reference.
- you must submit the letter of reference no later than the competition deadline.

The contents of this evaluation may be sent to the applicant who so requests, after the results are announced officially.

  - . the applicant's scientific proficiency and experience in relation light of the proposed research project;
  - . the scientific achievements in relation to those of applicants with a comparable university education profile.
- Position the applicant in relation to the other postdoctoral fellow you supervise.

- Evaluate the research project according to the following criteria:
  - . the precision and clarity of the theoretical approach and the objectives pursued;
  - . the relevance of the proposed methodology;
  - . the project's correspondence with the research priorities in the field.
- Evaluate the quality, the relevance and the added-value of the choice of research environment in light of the applicant's doctoral training
